

**ORDINANCE NO. 1329**

**AN ORDINANCE ALLOWING THE ADOPTION OF BYLAWS BY RESOLUTION,  
REPEALING ORDINANCE 1257, PLANNING COMMISSION BYLAWS, AMENDING THE CODE OF THE CITY OF  
TILLAMOOK (CCT), TITLE III, CHAPTER 32.01: PLANNING COMMISSION; BYLAWS**

**WHEREAS**, Oregon Revised Statute 221.916(1)(p) gives the authority of a common council to “Make bylaws and ordinances not inconsistent with the laws of the United States or of this state (Oregon);” and

**WHEREAS**, on September 6, 2011, the City adopted Ordinance No. 1257 establishing bylaws for the Planning Commission; and

**WHEREAS**, the City Planning Commission has reviewed and recommended changes to its bylaws; and

**WHEREAS**, no provision is in place that requires bylaws to be adopted by ordinance, and the City Council has determined to adopt bylaws by resolution.

**NOW THEREFORE**, the City of Tillamook ordains as follows:

**Section 1. Repealing Old Legislation.**

Ordinance No. 1257 and all other previously adopted ordinances, resolutions and enactments establishing bylaws for the Planning Commission of the City of Tillamook are hereby repealed.

**Section 2. Bylaws Adopted by Resolution.**

Bylaws for the City of Tillamook will hereafter be adopted by Council resolution, unless proscribed by law to be adopted in another manner.

**Section 3: Amendment of the Code of the City of Tillamook (CCT).**

The Code of the City of Tillamook (CCT) Title III, Chapter 32.01: Planning Commission; Bylaws is hereby amended to state the following: “Bylaws of the City of Tillamook Planning Commission shall be adopted by resolution.”

**Section 4: Codification.**

Provisions of this Ordinance shall amend the Code of the City of Tillamook, and the word “ordinance” may be changed to “code”, “article”, “section”, “chapter” or another word and the sections of the Ordinance may be renumbered, or re-lettered, the City Recorder is authorized to correct any cross-references and any typographical errors.

**Section 6: Effective Date.**

This Ordinance shall take effect 30 days from the date of adoption.
