Dear Bailey,

That is correct. The mask requirements are specific to the sorts of businesses and environments that are explicitly included in the guidance. The guidance doesn't include office settings that are not open to the public. In those settings teleworking to the maximum extent possible and distancing and sanitation protocols for the people who simply must come to the office is preferred. The phase of the county you are in is an important consideration. In phase 1 counties teleworking to the maximum extent possible is mandatory. For phase 2 counties teleworking is strongly recommended. In any case the mask guidance doesn't apply except for any "public areas" you may have in your facilities.

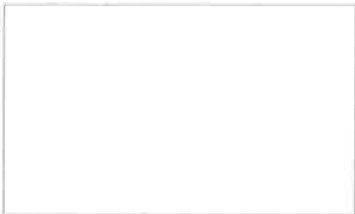
