A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF EL MIRAGE, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 3, 2020.

WHEREAS, the City of El Mirage, Maricopa County, Arizona did hold a General Election on the 3rd day of November 2020 for 2020 General Plan Update; and

WHEREAS, the election returns have been presented to and have been canvased by the City Council.
