ANY AMOUNT UP TO \$5,000.99	10%
\$5,001.00 TO \$15,000.99	5%
\$15,001.00 AND OVER	3%

FEE FOR WRITS OR ORDERS WHERE NO COMMISSION IS RECEIVED BY SHERIFF/CONSTABLE

Any Writ or Order fee is based on a two (2) hour, in the field fee. For those writs or orders that do not result in a commission to the Sheriff/Constable, a \$25.00 per hour/ per deputy fee will be charged for anything above and beyond two (2) hours in field.
