COMMISSIONERS COURT RESOLUTION AND ORDER

A RESOLUTION AND ORDER BY THE COMMISSIONERS COURT OF THE COUNTY OF NUECES, TEXAS, APPROVING THE CLOSURE OF NAVIGATION BOULEVARD, FROM 1400 FEET NORTH OF UP RIVER ROAD, NORTH TO THE END OF THE ROAD AT THE INNER HARBOR.

WHEREAS, The Port of Corpus Christi has requested the closure of a section of Navigation Boulevard (90 feet in width and 1,800 feet in length), and;

WHEREAS, The Port of Corpus Christi is the only property owner along both sides of the section of road to be closed, and;

WHEREAS, pursuant to Chapter 251 of the Transportation Code the Commissioners Court has the authority to close, abandon, and vacate public roads, and;

WHEREAS, in accordance with the Section 251.052 of the Transportation Code, a petition by at least eight property owners in County Commissioner Precinct No. 1 requesting the closure of a section of Navigation Boulevard has been presented to the Commissioners Court, and;

WHEREAS, in accordance with Section 251.052 of Transportation Code, notice of the proposed road closure was posted on the Courthouse door and at two other places in the vicinity of the affected route for at least 20 days before the date the application was made, and;

WHEREAS, the Commissioners Court of Nueces County, Texas finds that the proposed road closure will be of benefit to the security of the Port facilities and will not adversely affect the traveling public.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COMMISSIONERS COURT OF NUECES COUNTY, TEXAS that effective immediately a section of Navigation Boulevard, currently maintained by Nueces County, be closed from 1400 feet north of Up River Road, north to the end of the road at the inner harbor.
