The Palmer Drug Abuse Program is grateful for the \$5,000 received from Nueces County in FY 2014-2015. This funding helped us with our Preventative Program & Younger Group program services.

PDAP offers free 12-step support group services for teenagers (ages 12 to 17) and adults who express a desire to find an alternative to drug and alcohol use; for the parents who seek solutions to family and personal conflicts arising from drug or alcohol use by a family member; and for the younger brothers and sisters of drug abusing siblings or parents. Under the guidance of a trained and dedicated staff, PDAPers share their experience, love, and understanding, solve their common problems, and help others recover from the effects of mind-changing chemicals.

During 2015, our Younger Group program worked with **4,568 individuals** (including 1,297 newcomers), awarded **778 30-day fists** (for 30 days of continuous sobriety) and two one-year fists. Staff also logged **2,197 individual counseling** appointments.

We are in CCISD weekly and now have meetings at TAMUCC; we are very excited about being able to have a presence at the University and in the schools.
