## COMMISSIONERS COURT ORDER Order Ratifying Hiring of Property Info Corporation for Historical Book Scanning Project Services

**WHEREAS**, the Nueces County Commissioners Court entered into an agreement with Property Info Corporation (herein "Property Info") on April 25, 2012 (herein "2012 Services Agreement") for the provision of certain scanning and indexing services related to Nueces County Clerk historical books, such agreement having expired prior to such project being completed; and,

**WHEREAS**, Nueces County representatives consented to Property Info continuing to complete the project as contemplated in the 2012 Services Agreement;

**WHEREAS**, pursuant to section 262.024(a)(7) items that can only be obtained from one source do not require competitive bidding and the services as contemplated in the 2012 Services Agreement were designated as sole source by the Nueces County Purchasing Agent; and,

**WHEREAS**, the Nueces County Purchasing Agent by letter has designated the services provided by Property Info to complete the project originally set out in the 2012 Agreement as sole source; and,

**WHEREAS**, Property Info did provide valuable services to Nueces County as requested by County representatives such work having been provided;

**NOW, THEREFORE, BE IT PROCLAIMED AND ORDERED BY THE COMMISSIONERS COURT OF NUECES COUNTY, TEXAS**, that the hiring of Property Info for the work contemplated above is herein ratified. The Court specifically ratifies Property Info's hiring for the completion of the Nueces County Clerk historical books scanning and indexing project as set out in the 2012 Agreement. These services are through December 22, 2014. Fees for these services shall be consistent with the fees as set out and approved in the 2012 Services Agreement.
