AGREEMENT AMENDMENT NO. 2

WHEREAS, the County of Nueces (“**Client**”) and Staples Contract & Commercial, Inc., (“**Staples**”) entered into an Agreement on the effective date, November 18, 2015, for Copy Paper, Computer Paper, NCR Paper, and Envelopes (IFB No. 2998-15); and Amendment No 1 to the Agreement on May 25, 2016.

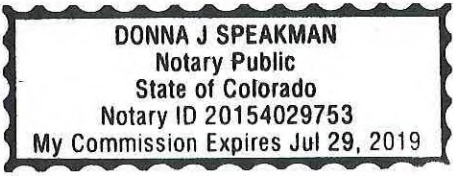
