WHEREAS, the County of Nueces ("Client") and LNV, Inc., entered into an Engineering Services Agreement on the effective date, April 1, 2015, for engineering services related to surface water lines and connections in Cindy Park Colonia (RFQ No. 2977-14); and Supplemental Agreement No. 1 to the Agreement on September 2, 2015; and

WHEREAS, the parties now want to exercise the option as set out in Article 3 of the Agreement to extend the term of the Agreement;

NOW, THEREFORE, Nueces County and LNV, Inc., in consideration of the mutual agreements contained in the original Agreement and additional time provided pursuant to this amendment do hereby mutually agree:

1. To exercise the extension option of 12 months as set out in Article 3 of the Agreement extending the termination date of the Agreement to November 23, 2017;
2. All other provisions of the Agreement and bidding documents, including the specifications, shall remain the same.
