## **SUPPLEMENTAL AGREEMENT NO. 2 NUECES COUNTY AND STRIDDE, CALLINS & ASSOCIATES, INC.**

**WHEREAS**, the County of Nueces and Stridde, Callins & Associates, Inc. entered into an Engineering Service Contract on November 19, 2014, (modified by Supplemental Agreement No. 1) herein referred to as “Contract”, for the preparation of plans, specifications, and construction phase services associated with the McKinzie Jail Annex Fire Alarm System Replacement; and

**WHEREAS**, Article 10 of the Contract establishes the method for changes in the scope, complexity, character, or duration of the services to be provided; and

**WHEREAS**, an extension of the Contract termination date is needed because of delays in a related construction project.

**NOW, THEREFORE**, Nueces County and Stridde, Callins & Associates, Inc. in consideration of the mutual agreements contained in the original Contract, and modified by Supplemental Agreement No. 1, do hereby mutually agree:

1. The second sentence of Article 3 - Contract Period is hereby withdrawn in its entirety and replaced with the following:

“This contract shall terminate at the close of business on December 31, 2018, unless extended by supplement agreement duly executed by the Engineer and County prior to the date of termination, as provided in Article 10 - Supplemental Agreements, or otherwise terminated, as provided in Article 19 – Termination.”

2. The first sentence of Article 19 - Termination is hereby withdrawn in its entirety and replaced with the following:

“This contract shall terminate at the close of business on December 31, 2018, unless extended as provided in Article 10 – Supplemental Agreements.”

3. All other provisions of the contract shall remain the same.
