I am submitting this report to Nueces County on activities by Family Counseling Service in performance of its obligation pursuant to Contract # 20170106

In July 2017, Family Counseling Service received Check No. 00727860 in the amount of \$15,000 for the Nueces County fiscal year of 2016 to 2017. These funds were used to help pay for therapy to underinsured and uninsured residents of Nueces County.

The following information contains data of those Nueces County residents served in October 1, 2016 to September 30, 2017.

There were 1,289 (35% Male; 65% Female) Nueces County residents that received therapy services from Family Counseling Service.
