## AGREEMENT AMENDMENT NO. 1

**WHEREAS**, the County of Nueces ("Client") and Gulf Coast Paper Co., ("Gulf") entered into an Agreement on the effective date, October 31, 2018, for Copy Paper, Computer Paper, NCR Paper, and Envelopes (IFB No. 3083-18; herein "Agreement;")

**WHEREAS**, Article II of the Agreement provides that Gulf notify the County ninety (90) days prior to expiration of then current term should it desire to exercise its twelve-month renewal option;

**WHEREAS**, Gulf timely notified the County of its desire to renew the Agreement for an additional twelve-months;

**WHEREAS**, the parties desire to memorialize this Agreement renewal through this Amendment No. 1;

**WHEREAS**, pursuant to the terms of the Agreement, in Article I, the unit bid prices for renewal period shall be re-determined at the beginning of the renewal period, any increase being subject to proof being submitted to the County to substantiate the increased amount; and

**WHEREAS**, Gulf has provided such proof indicating price increases.

**NOW, THEREFORE**, Nueces County and Gulf Coast Paper Co., in consideration of the mutual agreements contained in the original Agreement and additional time provided pursuant to this agreement do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in Article II of the Agreement extending the termination date of the Agreement to October 31, 2020;
2. To increased unit prices as set out in Exhibit A herein attached and incorporated for all purposes effective November 1, 2019.
3. All other provisions of the Agreement and bidding documents, including the specifications, shall remain the same.

The undersigned agent of Gulf is a properly authorized official and has the necessary authority to execute this Amendment on behalf of Gulf.
