In program year 2018-2019 the Rural Outreach program at Catholic Charities continued its efforts to promote Diabetes awareness and prevention information through coordination of services at satellite locations and the main office. Food pantries in Nueces County reached **20,906** households. The variance in the current program year from the previous program year was due to staff turnover in the Executive team, and staffing shortages.

Catholic Charities of Corpus Christi, Inc. services provide the ideal setting for dissemination of healthy lifestyle and public health information. Service providers can refer clients to the Rural Outreach coordinator for resources to manage their Type 2, Diabetes, and to develop healthy lifestyles for their families.

Satellite locations include Our Lady of Perpetual Help, Flour Bluff, and Oliver Court (main office). Program participants were assisted with resources connections for diabetes management, prevention, and early detection. Community resources included;
