

**CONTRACT**

**(NUECES COUNTY / NUECES COUNTY JUNIOR LIVE STOCK SHOW)**

This agreement entered into on the date of its execution as set forth below by and between Nueces County, hereinafter called "County," and Nueces County Junior Live Stock Show Association ("NCJLS Show Assn."), a non-profit organization in Nueces County.

**WITNESSETH:**

WHEREAS, the Commissioners Court finds that there is a need for programs to provide for the support and promotion of any phase of agriculture, homemaking, and industry through the Nueces County Junior Live Stock Show; and

WHEREAS, the Commissioners Court is authorized to appropriate and spend money from the county general revenues to provide for annual exhibits of agricultural, livestock and other products that are of interest to the community pursuant to § 319.001 of the Texas Local Government Code. The Commissioners Court is also authorized to appropriate and spend money from the county general revenues to provide for recreational programs pursuant to § 332.002 of the Texas Local Government Code;

NOW, THEREFORE, for and in consideration and exchange of mutual covenants and conditions contained herein to further the public purpose of providing the afore-mentioned, the County and the NCJLS Show Assn. agree as follows:

I.

NCJLS Show Assn. will promote and encourage the work of 4-H Clubs, FCCLA Chapters, FFA Chapters, and adult leaders of Nueces County in promoting any phase of agriculture, homemaking, and industry. NCJLS Show Assn. will provide program access or remove barriers to accessibility under the Americans with Disabilities Act to allow individuals with disabilities the opportunity to participate and receive benefits of services, programs and activities.

II.

NCJLS Show Assn. will submit an annual report to the County indicating services by NCJLS Show Assn. in performance of its obligations pursuant to this agreement. NCJLS Show Assn. shall include in its report a detailed accounting of expenditures of County funds and any measurable results. Such report shall be presented to the County Commissioners Court at a noticed meeting.

III.

NCJLS Show Assn. will diligently use its resources to provide the aforementioned services to the residents of Nueces County.

IV.

As payment for these services to be rendered in the County's fiscal year 2019-2020, the County will provide \$2,000.00 subject to appropriations for the administration of NCJLS Show Assn. services related to the purposes of this agreement pursuant to the 2019-2020 County Budget.

V.

NCJLS Show Assn. will cause this funding to be segregated from other funds used for services of NCJLS Show Assn. unrelated to the purposes of this agreement.

VI.

This agreement shall continue in force and effect until September 30, 2020. In the event NCJLS Show Assn. terminates its services related to the purposes of this agreement prior to the expiration of this agreement, the balance of any remaining funds shall be returned to the County in the same proportion that County funds bear to the total funds received or in the possession by NCJLS Show Assn. to conduct services related to this agreement.
