KNOW ALL MEN BY THESE PRESENTS

This agreement entered into on the date of its execution as set forth below by and between Nueces County, hereinafter called "County," and Burn Pits 360 ("Burn Pits 360"), a non-profit veterans organization in Nueces County.

WITNESSETH:

WHEREAS, the Commissioners Court finds that there is a need for programs to provide for the support of paupers, residents of Nueces County, who are unable to support themselves; and

WHEREAS, the Commissioners Court is authorized to appropriate and spend money from the county general revenues to provide for the support of paupers, residents of their county, who are unable to support themselves pursuant to §81.027 of the Texas Local Government Code;

NOW, THEREFORE, for and in consideration and exchange of mutual covenants and conditions contained herein to further the public purpose of providing for the support of paupers the County and Burn Pits 360 agree as follows:

I.

Burn Pits 360 will conduct a food drive and provide food to Nueces County paupers in need. Burn Pits 360 will provide program access or remove barriers to accessibility under the Americans with Disabilities Act to allow individuals with disabilities the opportunity to participate and receive

benefits of services, programs and activities.

II.

Burn Pits 360 will submit an annual report to the County indicating services by Burn Pits 360 in performance of its obligations pursuant to this agreement. Burn Pits 360 shall include in its report a detailed accounting of expenditures of County funds and any measurable results. Such report shall be presented to the County Commissioners Court at a noticed meeting.

III.

Burn Pits 360 will diligently use its resources to provide the aforementioned services to the residents of Nueces County.

IV.

As payment for these services to be rendered in the County's fiscal year 2019-2020, the County will provide \$2,000 subject to appropriations for the administration of Burn Pits 360 services related to the purposes of this agreement pursuant to the 2019-2020 County Budget.

V.

Burn Pits 360 will cause this funding to be segregated from other funds used for services of Burn Pits 360 unrelated to the purposes of this agreement.

VI.

This agreement shall continue in force and effect until September 30, 2020. In the event Burn Pits 360 terminates its services related to the purposes of this agreement prior to the expiration of this agreement, the balance of any remaining funds shall be returned to the County in the same proportion that County funds bear to the total funds received or in the possession by Burn Pits 360 to conduct services related to this agreement.
