**COMMISSIONERS COURT RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE OFFICE OF THE GOVERNOR, PUBLIC SAFETY OFFICE, CRIMINAL JUSTICE DIVISION FOR THE NUECES COUNTY COVID-19 RESPONSE PROGRAM UNDER THE CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING (CESF) PROGRAM, FY2020 (GRANT NUMBER 4160301)**

**WHEREAS**, the Nueces County Commissioners Court finds it in the best interest of the citizens of Nueces County that the Nueces County COVID-19 Response Program be operated for the County's 2019/2020 and 2020/2021 fiscal year and the State's FY2020 fiscal year;

**WHEREAS**, Nueces County agrees that in the event of loss or misuse of the Office of the Governor funds, Nueces County assures that the funds will be returned to the Office of the Governor in full;

**WHEREAS**, Nueces County designates the County Judge as the grantee's Authorized Official. The Authorized Official is given the power to apply for, accept, reject, alter, or terminate the grant on behalf of the applicant agency.

**NOW, THEREFORE, BE IT RESOLVED** that the Nueces County Commissioners Court authorizes the submission of the grant application for the Nueces County COVID-19 Response Program (eGrants #4160301) to the Office of the Governor, Public Safety Office, Criminal Justice Division under the Coronavirus Emergency Supplemental Funding (CESF) Program, FY2020.
