SUPPLEMENTAL AGREEMENT NO. 4

WHEREAS, Nueces County and LNV, Inc., entered into an Engineering Services Contract (herein "Agreement") on the effective date, July 22, 2015, for professional engineering services necessary for the implementation of a new ground water distribution system for Cindy Park Colonia (RFQ No. 2988-15); and Supplemental Agreement No. 1 to the Agreement on May 31, 2017; and Supplemental Agreement No. 2 to the Agreement on April 25, 2018; and Supplemental Agreement No. 3 to the Agreement on May 8, 2019.

WHEREAS, the County and LNV acknowledged in Article 10 of the Agreement that the terms of the contract may be modified by supplemental agreement if the County determines that there has been a significant change in the scope, complexity, or character of the services to be performed, or the duration of the work; and

WHEREAS, the County and LNV agree that the duration of the work set out in the Agreement must be modified.

NOW, THEREFORE, Nueces County and LNV, Inc., in consideration of the mutual agreements contained in the original Agreement and additional time and monies provided pursuant to this amendment, do hereby mutually agree:

1. The second sentence of Article 3 is hereby withdrawn in its entirety and replaced with the following:
"This contract shall terminate at the close of business on July 31, 2021."
2. The first sentence of Article 19 is hereby withdrawn in its entirety and replaced with the following:
"This contract shall terminate at the close of business on July 31, 2021 unless extended as provided in Article 10 – Supplemental Agreements."
3. All other provisions of contract shall remain the same.
