

FIFTH AMENDMENT
DETENTION SERVICES AGREEMENT
BETWEEN
NUECES COUNTY, TEXAS
AND
THE GEO GROUP, INC.

THIS FIFTH AMENDMENT dated and effective the 27th day of May 2020 is by and between Nueces County (“COUNTY”), a political subdivision of the State of Texas, and The Geo Group, Inc, a corporation duly qualified to transact business in the State of Texas (“GEO GROUP”).

WHEREAS, County and LCS Corrections Services, Inc. executed a Detention Services Agreement between Nueces County, Texas and LCS Corrections Services, Inc. dated August 25, 2004 (the “AGREEMENT”) and subsequently First, Second, Third, and Fourth Amendments to the Agreement on October 12, 2005, June 19, 2008, December 16, 2009, and November 1, 2013, respectively.

WHEREAS, in February 2015 LCS Corrections Services, Inc. upon approval of County assigned the Agreement to Geo Group, wherein Geo Group assumed the terms, conditions, and obligations under the Agreement;

WHEREAS, the Agreement states in section 6.8 Modification or Amendment, “No changes to this Agreement shall be made except upon written Agreement of the parties. None of the requirements set forth herein shall be modified without written authorization of the County. All modifications to this Agreement shall be in the form of Amendments signed by the County and LCS;”

WHEREAS, the parties desire to amend the Agreement at this time to provide of an increase in the per diem rate for inmates housed at the Nueces County detention facility;

NOW THEREFORE; in consideration of the mutual obligations set forth herein, the County and Geo Group agree as follows:

1. The parties agree to amend 1.5.1.2 as amended in the Third Amendment:

“For providing for the care and custody of Federal inmates in accordance with Section 1.2.2 above, a per diem fee of Forty-nine and 75/100 dollars (\$49.75) for those federal inmates housed at the East Hidalgo County detention facility and Fifty and 75/100 dollars (\$50.75) for those federal inmates housed at the Nueces County detention facility.”

To the following:

“For providing for the care and custody of Federal inmates in accordance with Section 1.2.2 above, a per diem fee of fifty-eight and 94/100 dollars (\$58.94) for those federal inmates housed at the East Hidalgo County detention facility and sixty-eight and 62/100 dollars (\$68.62) for those federal inmates housed at the Nueces County detention facility.”

IN WITNESS THEREOF, the parties have caused this FIFTH AMENDMENT to be executed by their duly authorized representatives.
