AGREEMENT AMENDMENT NO. 3

WHEREAS, the County of Nueces (“**County**”) and Navia Benefit Solutions, (“**Contractor**”) entered into an Agreement with the effective date of October 1, 2017, for Cafeteria Administration, Including Premium Only Plan (POP) and Enrollment Billing Services (RFP No. 3037-17), herein “**Agreement**”; and Agreement Amendment No. 1 on August 8, 2018; and Agreement Amendment No. 2 on August 14, 2019.

WHEREAS, the parties now want to exercise the option as set out in Section 2.2 of the Agreement to extend the term of the Agreement for 12 months, this being the third extension;

NOW, THEREFORE, Nueces County and Navia Benefit Solutions, in consideration of the mutual agreements contained in the original Agreement providing for a contract renewal term do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in Section 2.2 of the Agreement extending the termination date of the Agreement to September 30, 2021.
2. All other provisions of Agreement shall remain the same.

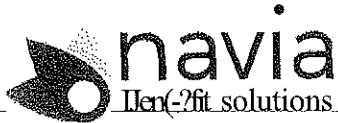
