## AGREEMENT AMENDMENT NO. 3

**WHEREAS**, the County of Nueces (“**County**”) and Dearborn National Life Insurance Company, (“**Contractor**”) entered into an Agreement with the effective date of October 1, 2017, for Group Term Life Insurance (RFP No. 3038-17), herein “**Agreement**”; and Agreement Amendment No. 1 on July 11, 2018; and Agreement No. 2 on August 14, 2019.

**WHEREAS**, the parties now want to exercise the option as set out in Article I of the Instructions to Proposers to extend the term of the Agreement for 12 months, this being the third extension;
