AGREEMENT AMENDMENT NO. 1

WHEREAS, the County of Nueces (“**County**”) and Boon-Chapman Benefit Administrators, Inc. (“**Contractor**”) entered into an Agreement with the effective date of August 14, 2019 for Network Services to Boon-Chapman citing the National Aetna Signature Administrators Network (RFP No. 3108-19).

WHEREAS, the parties now want to exercise the option as set out in the Agreement to extend the term of the Agreement for 12 months, this being the first extension;

WHEREAS, pursuant to the terms of the Agreement, specifically the Service and Fee Schedule, Services Item 1 Network Access Services Per Employee Per Month (PEPM) will be \$12.18 PEPM, instead of the prior, \$11.70, and all other fees will remain the same;

NOW, THEREFORE, Nueces County and Boon Chapman Benefits Administrators, Inc., in consideration of the mutual agreements contained in the original Agreement providing for a contract renewal term do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in the Terms and Conditions, extending the termination date of the Agreement to September 30, 2021.
2. All other provisions of Agreement shall remain the same.
