

AMENDMENT NO. 1 TO THE AGREEMENT

BETWEEN CITY OF CORPUS CHRISTI AND NUECES COUNTY

REGARDING PARKER POOL SWIM ADMISSION FEES

This Amendment No. 1 to the Agreement between City of Corpus Christi and Nueces County regarding Parker Pool Swim Admission Fees is made and entered by and between the County of Nueces, hereinafter referred to as "County", and the City of Corpus Christi, a Texas home-rule municipal corporation hereinafter referred to as "City";

WITNESSETH:

WHEREAS, in December 2018, the City of Corpus Christi and Nueces County entered into the Agreement between City of Corpus Christi and Nueces County Regarding Parker Pool Property For Utilities, Use of and Transfer of Property, ("the Agreement") providing for payment for utilities, and the use of and transfer of property located at or near 654 Graham Road: the swimming facility known as "Parker Pool", from the City to the County;

WHEREAS the Agreement provided for the County to provide a general public swim program at Parker Pool;

WHEREAS, the City has enacted free general swim program for the pools owned and operated by the City, and is promoting similar free or reduced general public swim program for the Parker Pool;

NOW THEREFORE, this Amendment No. 1 to the Agreement is made and entered into by County and City for the mutual consideration stated herein.

The parties agree to amend Section 2 B. of the Agreement regarding free or reduced public swim program to read as follows:

2. **DUTIES OF THE COUNTY**

B. County agrees to provide for operation of the Parker Pool Property as a public swimming pool, through the Lease or other means, with general public swim program open to the public for minimum of 20 hours per week, weather and conditions permitting and so long as City continues to provide payment as described herein for water, wastewater and electricity service for the property. County agrees to reduce the regular Parker Pool public swim admission fees as follows:

- 1) In 2020, County shall not charge Parker Pool public swim admission fee subject to receipt of payment of \$22,120.00 from the City within ten business days of date of last signature.
- 2) In 2021, County shall charge reduced Parker Pool public swim admission fee of \$1.40 subject to receipt of payment of \$16,415.00 from the City by April 1, 2021.
- 3) In 2022, County shall charge reduced Parker Pool public swim admission fee of \$2.70 subject to receipt of payment of \$ 8,975.00 from the City by April 1, 2022.

The parties agree to amend Section 3 of the Agreement by addition of new subsection C to read as follows:

3. DUTIES OF THE CITY

C. In consideration of the free or reduced general public swim program for minimum of 20 hours per week as described above in Section 2 subsection B, the City agrees to pay the County the amounts reflected in Section 2, subsection B, subject to City annual appropriation of funds. All payments made herein will be made from current revenues of the paying party. Payment shall be issued to the County to the following address:

The parties agree that all other terms of the Agreement remain in full force and effect except as amended by this Amendment No. 1.
