SERVICES OPERATION AGREEMENT BETWEEN NUECES COUNTY COURTS AND RECOVERY HEALTHCARE CORPORATION

ADDENDUM NO. 1

The following sections of the Agreement are amended as follows:

I. Agreement

- (a) This Agreement, herein "Agreement", is established between **Recovery Healthcare Corporation** and **Nueces County** for the benefit of its established **Drug Court Program and other Courts to include the Veteran's Treatment Court Program**, 901 Leopard Street, Corpus Christi, TX 78401 (361) 888-0444 for the provision of Continuous Alcohol Monitoring and Breath Alcohol Testing services to adult defendants/offenders.

VI. Evaluation Criteria

- (a) **Nueces County** through its **Drug Court Program and other Courts to include the Veteran's Treatment Court Program** shall evaluate **Recovery Healthcare Corporation's** performance under this Agreement according to the following specific performance goals:
- To provide reports on each defendant/offender in a timely manner.
- (b) **Nueces County** through its **Drug Court Program and other Courts to include the Veteran's Treatment Court Program** shall additionally evaluate **Recovery Healthcare Corporation** by the following output measures:
- All defendants/offenders being monitored are required to follow the requested schedule;
 - Reports are easy to read and differentiate.
- (c) **Nueces County** through its **Drug Court Program and other Courts to include the Veteran's Treatment Court Program** shall further evaluate **Recovery Healthcare Corporation** by the following outcome measures:
- Equipment is installed properly on all defendants/offenders;
 - Equipment is current and up to date;
 - Technical assistance is always available to the **Drug Court Program and other Courts to include the Veteran's Treatment Court Program**.



XIV. Termination

(a) This Agreement may be terminated:

- By either party upon ten (10) days written notice to the other party of the intention to terminate;
- Upon expenditure of available funds;
- If at any time during the term of this Agreement the **Nueces County Drug Court Program and other Courts to include the Veteran's Treatment Court Program**, in its sole discretion, determines that the safety of defendants/offenders being served under this Agreement may be in jeopardy the **Nueces County Drug Court Program and other Courts to include the Veteran's Treatment Court Program** may immediately suspend the effect of this Agreement including but not limited to the obligation to pay, upon giving notice to **Recovery Healthcare Corporation**;
- Upon 30 day written notice if either Party determines that the Agreement is no longer in the best interest of **Recovery Healthcare Corporation** or the **Nueces County Drug Court Program and other Courts to include the Veteran's Treatment Court Program**.
