AMENDMENT NO. 02

The Department of State Health Services (“**DSHS**”), a pass-through entity, and Nueces County (“**Grantee**”), collectively referred to in this Amendment as the "**Parties**," to that certain grant contract effective January 22, 2019, and denominated DSHS Contract No. HHS000371500014, now want to further amend the Contract.

Whereas, the Parties want to extend this Contract in accordance with the Texas DSHS FY 2018 Public Health Crisis Response (PHCR) Project No Cost Extension granted by the U.S. Department of Health and Human Services, on June 18, 2020.

The Parties therefore agree as follows:

1. The Contract is hereby amended to reflect a revised termination date of June 30, 2021.
2. This Amendment shall be effective as of December 31, 2020 or the signature date of the latter of the Parties to sign this agreement, whichever comes first.
3. Except as modified by this Amendment, all terms and conditions of the Contract shall remain in effect.
4. Any further revisions to the Contract shall be by written agreement of the Parties.


