## **COMMISSIONERS COURT RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE OFFICE OF THE GOVERNOR, TEXAS MILITARY PREPAREDNESS COMMISSION UNDER THE DEFENSE ECONOMIC ADJUSTMENT ASSISTANCE GRANT (DEAAG) PROGRAM FOR THE PURPOSES OF ACQUIRING AN AVIGATION EASEMENT AND/OR OTHER NONPOSSESSORY INTERESTS TO PREVENT ENCROACHMENT NEAR NAVY OUTLYING LANDING FIELD CABANISS**

**WHEREAS**, the Nueces County Commissioners Court finds it in the best interest of the citizens of Nueces County that Nueces County apply for funding from the Office of the Governor, Texas Military Preparedness Commission (State) under the Defense Economic Adjustment Assistance Grant (DEAAG) Program for the purposes of acquiring an avigation easement and/or other nonpossessory interests to prevent encroachment near Navy Outlying Landing Field Cabaniss;

**WHEREAS**, the State budgeted money for this grant program to assist military communities in Texas with infrastructure projects and other initiatives to increase military value and mitigate any potential negative effects to the military institutions in future Base Realignment and Closure (BRAC) rounds;

**WHEREAS**, acquiring avigation easements around the military institutions to protect them from encroachment issues is a tool that many other defense communities around the country have used to ensure the long-term viability of their local military institutions;

**WHEREAS**, the Naval Air Station – Corpus Christi (base) is a large employer of local civilian personnel and the base has a significant economic impact on the County and State, such that the proposed acquisition of an avigation easement and/or other nonpossessory interests could be deemed for a public purpose;

**WHEREAS**, Nueces County has worked with the local base to identify the property that would be viable for this program and anticipates total combined costs in the range of \$1,125,000 - \$1,275,000 with an anticipated grant cash match of \$307,000 which would be funded from 19012700 Major Capital Project Contingency;

**WHEREAS**, the Nueces County Commissioners Court through this resolution has authorized the Grants Administrator to submit a grant on behalf of the County.

**NOW, THEREFORE, BE IT RESOLVED** that the Nueces County Commissioners Court approves the submission of a grant application to the Office of the Governor, Texas Military Preparedness Commission under the Defense Economic Adjustment Assistance Grant (DEAAG) Program for the purposes of acquiring an avigation easement and/or other nonpossessory interests to prevent encroachment near Navy Outlying Landing Field Cabaniss.
