

AGREEMENT

This agreement made and entered into this 20th day of January , 2021, by and between J. Carroll Weaver, Inc., a corporation organized and existing under the laws of the State of Texas, hereinafter called "Contractor" and **Nueces County, Texas**, hereinafter called "Owner".

WITNESSETH, that the Contractor and the County for the considerations stated herein mutually agree as follows:

ARTICLE I STATEMENT OF WORK

The Contractor shall furnish all supervision, technical personnel, labor, materials, machinery, tools, equipment and services, including utility and transportation services, and perform and complete all work required for the Project, namely **IFB NO. 3145-20 Nueces County Roadway Rehabilitation Projects - County Road 22 & County Road 49** and required supplemental work for the project, all in strict accordance with the Contractual Documents, including all Addenda thereto, as prepared by **Freese and Nichols**.

ARTICLE II ENGINEER

Freese and Nichols or his authorized representative, is hereinafter called Engineer and is to act as OWNER'S representative, assume all duties and responsibilities and have the rights and authority assigned to Engineer in the Contract Documents in connection with completion of the Work in accordance with the Contract Documents.

ARTICLE III THE CONTRACT PRICE

The Owner will pay the Contractor for the performance of the Contract in current funds, for the total quantities of work performed for awarded total base bid and additive bid items at the prices stipulated (**as the official bid amount total in the Lump Sum**) Bid Form of this Contract Document for the several respective items of work in the amount of Two million, eight hundred, seventy six thousand, six hundred thirty two dollar and forty-one cents.

(\$ 2,876,632.41) completed subject to additions, deletions, and/or revisions as provided in the General Conditions of Agreement included in these Contract Documents.

ARTICLE IV CONTRACT TIME

The Work will be completed within 590 calendar days after the date stated in the Notice to Proceed.

ARTICLE V CONTRACT

The Executed Contract Documents shall consist of the following:

1. This Agreement
2. Nueces County Uniform General Conditions for Road and Bridge Construction Contracts
3. Addenda, if issued
4. Specifications and drawings
5. Special Provisions
6. Signed copy of this bid
7. Instructions to Bidders
8. General Requirements
9. Advertisement for Bids

THIS AGREEMENT, together with the other documents enumerated in **ARTICLE V**, which said other documents are fully a part of the Contract as if hereto attached or herein repeated, forms the Contract. In case of conflicts with any provision of any other component part, the provision of the component part first enumerated in this **ARTICLE V** shall govern, except as otherwise specifically stated.

RETAINAGE in the amount of five percent (5%) shall be withheld on all Partial Payments until Completion and Final Acceptance of the work by the Owner.

It is expressly understood by County and Contractor, that from the date of award of bid to one (1) year after termination or expiration of contract term, it is prohibited for any county official or employee thereof, to receive gifts described by Section 5.02 of the County Personnel or Civil Service Rules, and or campaign or political contributions regardless of amount from Contractor or principal owners of said Contractor. County official is defined as those individuals described as county and precinct officers in Subchapter B of Chapter 152 of the Local Government Code. Contractor is furthermore prohibited from making political, campaign, or personal contributions to candidates for county and precinct office from the date of award of bid to one year after termination or expiration of contract term. It is also prohibited for Contractor to contribute to employee associations or for the benefit of groups of employees.
