COMMISSIONERS COURT RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE OFFICE OF THE GOVERNOR, PUBLIC SAFETY OFFICE, CRIMINAL JUSTICE DIVISION FOR THE NUECES COUNTY FELONY DOMESTIC VIOLENCE COURT PROGRAM UNDER THE GENERAL VICTIM ASSISTANCE GRANT PROGRAM, FY2022 (GRANT NUMBER 3799703)

WHEREAS, the Nueces County Commissioners Court finds it in the best interest of the citizens of Nueces County that the Nueces County Felony Domestic Violence Court Program be operated for the County's 2021/2022 fiscal year and the State's FY2022 fiscal year;

WHEREAS, Nueces County agrees to provide applicable matching funds for the said project as required by the General Victim Assistance Grant Program, FY2022, grant application;

WHEREAS, Nueces County agrees that in the event of loss or misuse of the Office of the Governor funds, Nueces County assures that the funds will be returned to the Office of the Governor in full; and

WHEREAS, Nueces County designates the County Judge as the grantee's Authorized Official. The Authorized Official is given the power to apply for, accept, reject, alter, or terminate the grant on behalf of the applicant agency.

NOW, THEREFORE, BE IT RESOLVED that the Nueces County Commissioners Court authorizes the submission of the grant application for the Nueces County Felony Domestic Violence Court Program (eGrants #3799703) to the Office of the Governor, Public Safety Office, Criminal Justice Division under the General Victim Assistance Grant Program, FY2022.
