## COMMISSIONERS COURT RESOLUTION Hector Salinas Jr. (March 3, 1945 – April 30, 2021)

**WHEREAS**, Hector Salinas, Jr. was born on March 3, 1945 in Elsa, Texas and went on to graduate from Mary Carroll High School in Corpus Christi, Texas;

**WHEREAS**, from an early age Salinas fell in love with baseball;

**WHEREAS**, his career included coaching baseball at Carroll, Miller and Moody high schools leading Moody to its first playoff season in 1974 and its first appearance in the state tournament three years later;

**WHEREAS**, Salinas served as head baseball coach at Texas Southmost College in Brownville, Laredo College, and Texas A&M University – Kingsville; as well as coaching at Texas A&M University – Corpus Christi where he earned the NCAA Independent Coach of the Year;

**WHEREAS**, Salinas was inducted as a member of the Moody Hall of Fame (2000); Rio Grande Valley Sports Hall of Fame (2009) and the Texas A&M University-Kingsville Hall of Fame (2013);

**WHEREAS**, Salinas after retiring from coaching served on the Corpus Christi Independent School Board and the Del Mar College Board of Regents where he was a strong advocate of student education, needs, and ensuring all had opportunity to learn.

**NOW, THEREFORE, BE IT RESOLVED, BY THE COMMISSIONERS COURT OF NUECES COUNTY**, hereby honors the memory of Hector Salinas Jr., for his lifetime of accomplishments and service to our community, and hereby encourages the citizens of Nueces County to join the Court in offering condolences to the Salinas family in this time of mourning.
