## ORDER OF COMMISSIONERS COURT

**WHEREAS**, County Commissioners Court (“Court”) is responsible for procuring, selecting, and awarding a contract to provide a licensed professional Engineering firm for a licensed professional Engineering firm for engineering services for the Nueces County Regional Drainage Master Plan Study - Nueces County Drainage District No. 2 (NCDD2) Service Area, which includes grant funding from the Texas Water Development Board (TWDB) Flood Infrastructure Fund Program;

**WHEREAS**, the County will select and award such professional contract and engage such services based on demonstrated competence and qualifications for the type of professional services to be performed pursuant to Chapter 2254 of the Texas Government Code;

**WHEREAS**, the Purchasing Agent recommends that the Court procure these services through a Request for Qualification as authorized under Section 2254.003 of the Government Code;

**WHEREAS**, the Purchasing Agent is requesting that the court delegate the authority to evaluate all proposals in accordance to the criteria in the advertisement and to appoint several members to the evaluation committee. The appointed committee will meet to evaluate all the proposals and make a recommended selection to the court;

**WHEREAS**, the Court considered the procurement method for a licensed professional Engineering firm for a licensed professional Engineering firm for engineering services for the Nueces County Regional Drainage Master Plan Study - Nueces County Drainage District No. 2 (NCDD2) Service Area and the designation of an evaluation committee; and

### **NOW, THEREFORE, THE COURT MAKES THE FOLLOWING FINDINGS AND ORDERS;**

The Court finds and **ORDERS** the method of procurement for a licensed professional Engineering firm for a licensed professional Engineering firm for engineering services for the Nueces County Regional Drainage Master Plan Study - Nueces County Drainage District No. 2 (NCDD2) Service Area through a Request for Qualifications as authorized by Section 2254.003 of the Government Code. The Court finds and **ORDERS** the following as the designated representative (“Designated Representative”) for the assistance in the selection of a company to provide a licensed professional Engineering firm for a licensed professional Engineering firm for engineering services for the Nueces County Regional Drainage Master Plan Study - Nueces County Drainage District No. 2 (NCDD2) Service Area. The Designated Representative shall be

a committee comprised of those who occupy the following positions: the Purchasing Agent, Nueces County Drainage District No. 2 (NCDD2) Board Chairman, NCDD2 Office Manager, and one (1) NCDD2 designee and the County Judge or her designee. The Designated Representative shall be advised by the Court's Qualified Professionals, including Susan Roth Consulting. In the event that any of the persons designated above is unable to serve for any reason, the persons serving on the committee (i.e. Designated Representative) may continue to serve as the Designated Representative without the participation by such a person without diminishing its authority provided.

The Designated Representative shall evaluate the proposals of the proposers for demonstrated competence and qualifications, enter into negotiations with the recommended proposer and, after negotiations, and shall make its recommendation to the Court. Thereafter, the Court shall select the responsible proposer whose proposal is determined to demonstrate competence and qualifications and award a contract to perform the service for a fair and reasonable price resulting from negotiations in accordance to Section 2254.003 of the Government Code.
