

ASSIGNMENT AGREEMENT

- 3. Assignor represents, and Assignee accepts, that there are not claims or demands against the Assignor arising out of or related to the performance under this Assignment to the effective date hereof.
- 4. The Effective Date of the Assignment is January 31, 2020.
