COMMISSIONERS COURT PROCLAMATION "Recognizing May 8, 2021, as Captain Robert Batterson Day"

WHEREAS, Robert Batterson was born on May 8, 1921, in Mason City, West Virginia;

WHEREAS, following graduation from high school in 1938, he joined the United States Navy and completed boot camp in Norfolk, Virginia;

WHEREAS, Batterson was assigned to the U.S.S Philadelphia (CL-41) which was anchored at Pearl Harbor on December 7, 1941;

WHEREAS, Batterson is one of the last remaining survivors of the Pearl Harbor attack;

WHEREAS, in 1942, Batterson was selected to enter the V-5 Naval Aviation Program, being commissioned at Naval Air Station- Corpus Christi on September 6, 1944;

WHEREAS, Batterson flew F6F Hellcats in 1945 with VF-1 off of the U.S.S. Bennington (CV-20);

WHEREAS, after the surrender of Japan, Batterson stayed on in the Navy as a Supply Corps officer

WHEREAS, in 1974 Batterson retired as a captain after serving for thirty-five (35) years;

WHEREAS, Batterson served as one of the first volunteers on the U.S.S. Lexington in 1992, prior to its official opening;


WHEREAS, Batterson continues to volunteer on the U.S.S. Lexington where you can normally find him sharing his experiences with visitors in the Pearl Harbor exhibit;

WHEREAS, May 8, 2021 is Capt. Robert Batterson's, 100th birthday. Join us in honoring and celebrating Capt. Batterson.


