Option 1 – “Above and Beyond”

SB 1383 Requirements

• Fund the \$2 Million requested by the Yolo Food Bank and direct staff to create new SB 1383 tax on businesses who generate edible food that can be recovered.	\$2,000,000 (Year 1)- Direct all funding to Yolo Food Bank
	\$71,541 (Annually) - Approve the addition of one part-time Recycling Coordinator
	<u>\$317,990</u> (Annually) – Approve the addition of two full-time EH Inspectors
	\$2,389,531 Total Year 1 Cost

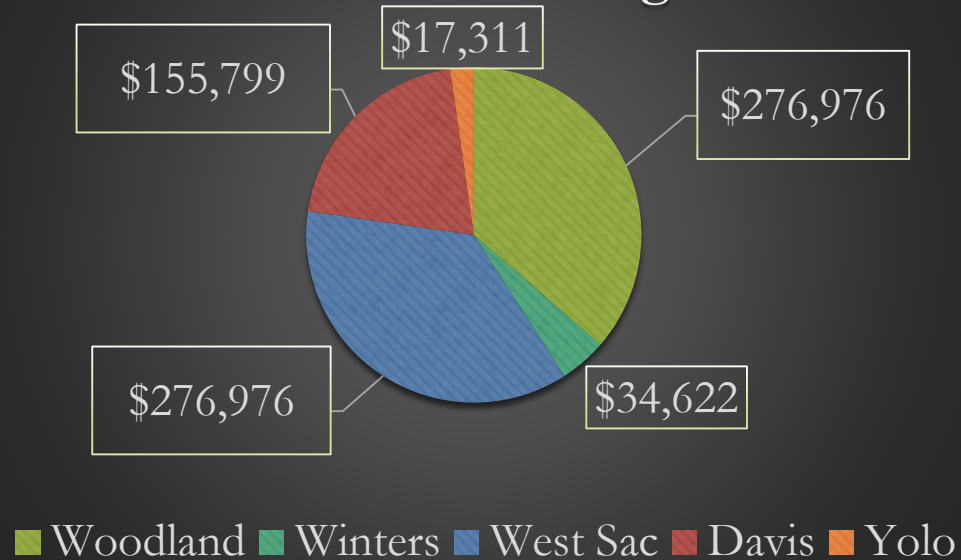
Option 2 – “Bare Minimum” SB 1383 Requirements

Option 3 – Staff Recommendation

SB 1383 Requirements

Total Year 1 Cost for all jurisdictions combined

1. Fund Yolo County's portion of Year 1 costs (**\$17,311**) and direct staff to take a regional food recovery network approach.

Partner with 9 Food Recovery Organizations

2. Recommend Tier 1 generators work with the 9 food recovery organizations highlighted in capacity study:

- These 9 organizations already use Feeding America guidelines and have existing capacity available.
- Yolo County Environmental Health (EH) has reviewed for H&S.
- List is not static and other organizations can be added at anytime with EH approval.

3. Fund the expanded capacity for these 9 food recovery organizations in the estimated amount of \$375K after review and approval by the jurisdictions.

Partner with Yolo Food Bank



4. Fund the Yolo Food Bank (YFB) for capacity assistance in the estimated amount of \$387K:
 - The YFB plays an essential role in the countywide edible food recovery program.
 - All City and County staff agree with the findings outlined in the Capacity Study and Funding Assessment.
 - Each specific funding line item will be reviewed and approved by the jurisdictions.
5. Use the CalRecycle Model Calculator tonnage for our baseline measurements.

6. Create an internal Edible Food Recovery MOU to identify jurisdictional roles, responsibilities and division of expenses.
